Depot Property – On hold while deed searching.

#### Dunlap Park –

- Davis & Floyd wants to schedule during office hours to present. Council discussed availability over next two weeks for scheduling.
- Mayor Scoggins stated that if anyone is parked in front of double gates, to call Sheriff's Office to handle towing. Eddie stated there have been several times that he has gone to the park to do lawn maintenance and had to reschedule visit due to vehicles parked in front of entrance.
